Water Infrastructure Modernization Project II (WIMPII) – Short Description

Georgia has received a loan in the amount of EUR 40 million from the European Investment Bank (EIB) toward the cost of the Water Infrastructure Modernization Project II, and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be delivered under this project. This project will be jointly financed by the EIB, Asian Development Bank (ADB), Neighbourhood Investment Facility (NIF) and Government of Georgia.

The investments will improve water supply and sanitation services, which will have a positive environmental and public health impact with an overall benefit to quality of life in selected 28 municipalities. Improved and efficient services provided by the United Water Supply Company of Georgia (Promoter) will increase financial sustainability of the sector.

Procurement of contracts co-financed by the European Investment Bank will be conducted through the procedures as specified in EIB's Guide to Procurement, June 2011, and is open to all bidders from Eligible Source.
