<b>Other details:</b>	1] The prospective bidders can create their bid online only after payment tender fee. Indian Agents can not purchase tender documents on behalf of their foreign principals, in case of e-procurement tenders. The payment of tender fee through electronic payment gateway can be made using Credit Cards. Foreign bidders are also allowed to purchase tender document by making e-payment using Credit Cards issued either in India or outside India. Any subsequent reversal/non-realisation of e-payment would lead to

rejection of bids submitted by such bidders. 2] Bidders shall furnish with their un priced Techno-contractual bids, a Bid Security for US\$ 1,000,000/- (US Dollar One Million Only) for Foreign bidders and Rs.5,00,00,000/- (Indian Rupees Five Crores Only) for Indian bidders against the Tender, valid for a period of 150 days from the date of opening of Un priced Techno-Contractual Bids. The bid shall be valid for a period of 120 days from the date of opening of Unpriced Techno-Contractual Bids. 3] Pre-bid conference will be held on 16.06.2017 at 1100 Hrs. (IST) at ONGC, Conference Hall, 4th Floor, 11 High Building, Bandra-Sion Link Road, Sion (W), Mumbai-400017 for the purpose of clarification, if any, of points on technical and commercial issues relating to the Bidding Documents. The bidder is requested to submit any query / clarification on Bidding Documents in writing to reach the Company on or before 15.06.2017 by 1730 Hrs. (IST), for the purpose of discussion in pre-bid conference through e-procurement portal only. No further queries / clarification on bidding documents will be entertained / accepted by the Company thereafter and in such case bidders shall not wait for any clarification from the company. The bidders shall send any request for clarification in the Pre bid conference only through e-procurement site of the company subject to payment of tender fee or obtaining exemption from payment of tender fee; clarification/query sent by other modes like post/fax/email will not be considered. 4] Bidders are advised to depute their authorized & accredited representative preferably of the rank of Executive Director level or equivalent to attend pre-bid conference to take decision across the table, lower level officer of the bidders without accompanying their senior officers shall not be allowed to attend Pre bid conference. Bidders are advised to download the tender documents well in advance prior to the pre-bid conference date, providing sufficient time for response. All bidders who download bidding documents are invited to attend the pre-bid conference subject to payment of tender fee or obtaining exemption from payment of tender fee. 5] Any modification to the Bidding Documents listed in Clause 2.0 of IFB, which may become necessary as a result of the pre-bid meeting, shall be made by the Company exclusively through the issuance of an amendment pursuant to Clause 8.0 of Part-I of the Bidding Documents and not through the minutes of the pre-bid meeting. 6] Non attendance at the pre-bid conference shall not be a cause for disqualification of a bidder. Exceptions/deviations if any, to tender terms, conditions & specifications are to be sorted out during Pre-Bid Conference (PBC), before submission of Bids. ONGC expects bidders to confirm compliance to tender terms, conditions & specifications which have been frozen after PBC, failing which the Bids are liable to be rejected. 7] Bids (both Unpriced Techno-contractual and Priced) shall be submitted online with required documents latest upto 1600 Hrs.
