People and cities are struggling with impossible rents and property prices, housing transformations and deportations, with speculation and enrichment, investment withdrawal, privatization, and destruction of urban heritage. The creation of appropriate policies for all these processes is an act of social regulation of the real estate market, laid down in the strategy of the New Urban Agenda of Habitat III. Social does not mean devaluation, it is an affordable standard. It means that the environment corresponds to the economic standard of the settlements, that consciousness and responsibility of the population are in compliance with these standards. And the policies have been created in dialogue with the environment.

UNECE supports the countries in Europe in implementing the 2030 Agenda and the Sustainable Development Goals (SDGs). Supporting the decision-making process based on evidence and reliable statistics and improved monitoring, analysis and policy advice. It encourages cooperation between all stakeholders at national and regional level. Encourages building the capacity of countries to apply their norms, conventions and standards that offer practical tools for improvement of the everyday lives of the people.
