Public establishment of electricity for generation announces for the second time its need for designing, manufacturing, supplying, transporting, insuring, testing, executing civil works, erecting, putting into operation for all equipment, machineries and necessary tools for the execution of a photovoltaic power plant with a capacity of /23/ M.W at Al- nasserich power plant – Damascus countryside Province - on turn-key basis including the supplying of spare parts and tools, internal training for personnel from PEEG with all needs to guarantee the safe operation and exploitation. In addition to provide the finance for this project through payment facilities.

All firms are invited to participate in the call for tenders. This will be according to the conditions specified in the file of Internal-External Call For Tenders No.343/2019. Those interested in participation can obtain a copy of the file from the contracts and loans department in the Establishment between 11-12.30 a.m during the official business hours and against (100) Euro for foreigners and Arabs non Syrian or (50000) Syrian pounds for Syrians .

- **Sections of the project:** the project consists of 3 sections:
  - The first section with a capacity of /7/ M.W.
  - The second section with a capacity of /7/ M.W.
  - The third section with a capacity of /9/ M.W.
- **Bid bond:** /230 000/ Euro only two hundred and thirty thousand Euro or its equivalent in one of the foreign currencies accredited by Central Bank of Syria or equivalent in the local currency as per the exchange rate of Central Bank of Syria on the day of presentation.
- **Performance Bond:** not requested.
- **Execution period:** the total execution period for each section is as follows:
  - The first section: /18/ months.
  - The second section: /36/ months.
  - The third section: /60/ months.

It starts from the next day of the date of commencement order.

• **Criteria basis that will be used for tender evaluation will be as follows:**

The total Technical marks are 100 marks, these marks are distributed as follows : (company reference /10/ marks, photovoltaic panels /50/ marks- plant performance /8/ marks- measuring and monitoring systems /2/ marks- electrical equipment /20/ marks- civil Works /10/ marks).

- The offer which will score less than 70% marks will be rejected .

- **Option period:** (120) days, from the next day of the closing date for submitting the offers.
- The Bidder has to be bound with the regulations of all books of conditions especially paying the taxes and duties .
- Offers should be presented before the end of the official business hours of 20/4 /2020 to the registration office of PEEG at Mazzeh -- 17 Nissan street - in front of Carlton hotel - Damascus, Syrian Arab Republic.
