- Founding member of the EU
- 1rst Presidency of the Council of the EU (EEC) in 1958
- 13th Presidency of the EU

    Defending the principles of democracy, the rule of law and fundamental rights will be an essential element in the work of the Belgian Presidency of the Council.
  - Strengthening our competitiveness

    The Belgian Presidency wants to focus on how we can help our companies, our industries to deal with the green and digital transition in the best possible way,
  - Pursuing a green and just transition

    Our Presidency will have 3 major priorities in this area: working towards a just transition, adapt to climate change and enhance our resilience, and move towards a circular economy.
  - Reinforcing our social and health agenda
    The Belgian Presidency will defend an ambitious future social and health agenda.
  - Protecting people and borders

    The Belgian Presidency will work towards a Europe that protects its people as well as its borders.
  - Promoting a global Europe

To adapt to the strain faced by the multilateral system and the rules-based international order, the Presidency will vigorously pursue the efforts made by the EU to strengthen its resilience and autonomy and defend its interests and values.
