# Accommodation for foreign guests:

Organizers will arrange accommodation for foreign guests in the official CIF hotels (typically 2 nights, 15 - 17 October 2018) based on the demand stated in the online registration.

The participants choose their preferred hotel (up to its capacity) in the registration.

The participant shall send the whole accommodation fee via a bank transfer to the bank account of the Chamber or designated production company. The fee depends on the selected and confirmed hotel and shall be sent by 30 September 2018.

If the participant fails to pay the accommodation fee in advance, the registration will be automatically voided. You can cancel your registration free of charge by 30 September 2018. The cancel fee is 100 % afterwards.

The following guests do not need to pay the accommodation fee: the protocollary highest representative of the PRC (1 person), the protocollary highest non-Czech CEE representative (1 person), panel speakers.
