Executive Summary

- ZK Pelagonija Group is the leading agro business and one of the largest conglomerate in North Macedonia
 - The Group consists of 7 related entities with parent company ZK Pelagonija jsc Bitola
 - The Group is vertically integrated system having a full control on the processes from the production of raw materials to the production of final products
 - The main income drivers of the Group are ZK Pelagonija, Dairy Zdravje, Pelagonija Energy
- Total agricultural land of the ZK Pelagonija Group amounts to 18,680 ha
- Main business activities are agriculture, production of dairy products and production of a biogas renewable energy
 - ZK Pelagonija is one of the largest agricultural companies in Southeast Europe, operating 17,296 ha of fertile land on a single location, of which 8,000 ha is covered by irrigation systems; in addition, the company is engaged in a production of animal feed and operates a cattle farm
 - Skopsko Pole used to be a large agricultural combine near capital city Skopje (~20 km) with total area of 1,384 ha of arable land; one part of the land is located immediately next to the international highway Corridor 10 linking Europe and the Middle East; suitable for real estate development
 - Dairy Zdravje is the leading producer of dairy products in North Macedonia with installed daily production capacities of up to 160 t
 - Pelagonija Energi is one of the largest biogas company in Southeast Europe, operating two biogas plants with total electricity output power of 6 MW with fixed feed-in tariff in the amount of 18 €¢/kWh, valid until 2030
- The Group has a significant brand awareness on the domestic market with high demand for its products










- Today the holding company comprises 11 related companies, making it a vertically integrated agricultural system where each step in the whole production process is closely monitored












Micro Location



Wheat

ZK Pelagonija produces numerous varaety of high quality wheet whit the help of variouse sceintific institutions



Barley

High quality varieties are used in cultivation of barly which leads to high yield of barly, produced for the needs of ZK Pelagonija as well as for the external sale.



Lucerne

Lucerne culture as the leading production in ZK Pelagonija, mainly beacause this culture is used for healty and well balanced animal food which will enable sustainable farming.



Sunflower

ZK Pelagonija has introduced high quality hybrids into the producton and achieved significantly high yields of more than over 3.000 kg per hectare



Soya

Large investments are made for this culture: enlarging the arable area under soya and sowing several seed sorts, in order to make the proper seed choice, adequate for the agro-environmental conditions of this region



Grass mix

Weeds are great source for animal food. They protect the soil from erosion, and threated with relevant care, the farm will benefit a lot from this culture



Oil seed rape

The excellent climatic conditions as well as the high level of technical-technological knowledge are the reason for the high yield of oilseed rape



Sorghum

Even though small area is occupied with this culture, it is enough for ZK Pelagonija to receive high quality feed and it is useful for production of concentrates



Cherries

The altitude of more than 600 meters is excellent place fo the development of this culture, combining the proper technology ZK Pelagonija aim for better productivity and quality



Tomatoes

After years of stagnation, the tomatoes are again a lucrative crop. ZK Pelagonija invest a lot of resources in processing this crop from modern machinery and technology to cutting edge techniques and high quality seed material.







Irrigation Systems

Overview

- Approx. 46.3% of the arable land is covered with modern irrigation infrastructure
 - Total 8,000 ha of the land is covered irrigation infrastructure
- The entire system is being dug up with pipelines where the water pressure is above 5 bar
- Part of area is irrigated throught arterial wells that have the capacity to supply water to any irrigation machine
- Linear irrigation machines covers 2,080 ha
- Irrigation with Bauer typhoons covers 2,000 ha

Irrigation Map of ZK Pelagonija



















Land in Long Term Lease and Possibility for Conversion to Ownership

- Total area of the land in long term lease amounts to 16,789 ha
- In 1998 ZK Pelagonija has concluded long term lease of agricultural land on a 30 years period
- Rent amount is equivalent to the price of wheat in the following proportion:
 - Annual rent for 1 ha of plains area is equivalent to 300 kg of wheat price
 - Annual rent for 1 ha of mountain area is equivalent to 100 kg of wheat price
- Possibility to gain ownership of the land at the price 2,000-2,500 EUR/ha (subject of negotiation with the Government) which can be preformed before the closing of potential transaction


Overview

- Additional agricultural capacities are located in Skopsko pole
 - Located next to the river Vardar
- Skopsko pole used to be the largest agricultural combine near capital Skopje in municipality Petrovec
- Combine owns arable land, vineyards and sheep farm
 - Total area of the arable land: 1,384 ha
 - Total area of the vineyards: 78 ha
 - Total number of sheep farms: 12
- Possibility to developed approx 250 ha of fruit growing or viticulture on the parcelc located on higer altitude
- The lower plots have the possibility of irrigation through a pumping station
 - Location preferable for gardening of pepper and tomato
- Additionally, possibility to develop up to 60 ha of bony fruits or hazelnuts
 - Location with the higher altitude

Production of Animal Feed

- ZK Pelagonija ownes a manufacturing facility for production of animal feed as well as the seed treatment center located in municipality Mogila, close to Bitola
- ZK Pelagonija produced animal feed concentrates largely for own purposes, but also a part of the produced concentrates is for sale
- Under the guidance of highly qualified technologists and cutting-edge production line, concentrates are produced for all categories of cattle
- Products are largely made from own agricultural products following prescribed recipes that meet all the standards of concentrate production
- In 2019 total produced concentrates amount to 7,776 t

Production Complex

The production complex consists of the following facilities:

- Large Concrete Silos 10,000 t capacity
 - The silos has a cereal drier with capacity 26 t/h on extra wood fuel, and a drier on methane with the capacity of 60 t/h
 - Used for storing grain materials (wheat, wheat, barley, etc.)
- Small Concrete Silos 4,400 t capacity
 - Used for storage of grains and flours
- Production Facility
 - Consist of the new and the old part directly connected with the large and small concrete silos
 - Owns a Center for seeds treatment
 - Also owns a Laboratory for control of the raw material as well as for the final product in order to obtain high
 quality goods; Additionally the moisture control and the control of the quality of cereal are conducted prior to
 the harvest

Introduction

- ZK Pelagonija owns a cattle farm and fishery, while sheep farm was operated by company Skopsko pole
- Cattle farms are strategically positioned near the biogas plants in Porodin and Logovardi and animal feed factory in Mogila
- Farms owns necessary mechanization and are fully equipped in accordance to the European standards
- Raw cow and sheep milk obtained from farms is being distributed to the dairy Zdravje Radovo
 - Milk is produced according to European standards with special attention to hygiene and high quality nutrition combination
- Annual production of cow milk in 2019 amounts to 12,745 t
- Annual production of sheep milk amounts to 92.6 t
- Annual production of consumer fish in 2019 amounts to 50,111 kg










Current Developments

Overview

- Shareholders and some of related companies have entered into period of low liquidity and reduced support from banks, while the investment into new capacity in Bitola was finalizing
 - In last 2 years around 3.6 mil EUR was invested in Bitola factory
- Unfortunately, due to non matching financing structure (long term investments with short term funds)
 which was not adjusted as planned, the company entered into negative cash flow cycle
 - Total loans on 30th of September 2019 amounted to 4.65 mil EUR, 3-6 years maturity, interest rate 4-5.5%
- Although the production significantly descent there is still excellent strong brand awareness, stable and increasing domestic demand for Dairy Zdravje products
- The company has a license to export in EU and Russia
 - The company is currently exporting parmesan to Russia
- With small intervention in working capital, sales figures can be very easily restored to the level close to 2017/2018 figures (on domestic market and export)



 - The company has 10 more years of collecting income as a privileged producer

- The company uses as a fuel, silage maize and animal manure distributed from ZK Pelagonija
- The electricity is sold to grid operator at fixed price of 0.18 EUR per KW/h



Proposed Transaction Structure

Overview

Percentage of shares available for purchase

- Orka Holding with its partners, owners of 84% of shares, are willing to offer their shares for sale
- Also, there is possibility to acquire up to 16% of remaining shares via take over-bid or in direct negotiations with small shareholders

Acquisition vs Joint Venture

- Prospective buyer is free to choose either purchase of shares from the shareholders, or joint venture with Orka Holding
- Orka Holding is a flexible seller and it is willing to sell all of its shares, or to remain in Pelagonija ownership
 as a minority shareholder with 20% to 30% of the total ownership, if such option is preferred by the buyer
- Orka Holding is willing to support future joint venture with it's local market knowledge and management
- Joint venture structure would preferably have an appropriate Put/Call option for Orka Holding

Legal Status of Leased Agricultural Land

- It is possible to have extension of the long-term lease for the land as condition precedent for the closing of the transaction
- Alternatively, it is possible to gain ownership of the land at the price 2,000-2,500 EUR/ha (subject to negotiations with the Government) which can be preformed before the closing of potential transaction
- The same applies for potential conversion of adequate proportion of agricultural land at Skopsko polje to construction land for future real estate development projects


