High-Tech Industry Park Craiova

Good practices in the field of Cultural and Creative Industries (CCIs) in the context of Urban Regeneration (UR)

The industrial park aims at the sustainable development of the eastern metropolitan area of the municipality of Craiova by attracting private investments that generate stable jobs in this area. It is dedicated to development of new technologies including in the creative industries. It manages the business infrastructure for a period of 30 years, on the green-field land provided by Dolj County through the County Council lands that form a compact body of approx. 30 hectares.

Investors-residents of the industrial park will benefit from all the facilities provided for in the Romanian legislation on the establishment and operation of industrial parks in Romania. It was realized under own funds of Local Administration and with Structural Funds, having as objectives an infrastructure / multifunctional center for organizing exhibitions, fairs or congresses / conferences / development new companies, attract investors. The initiator was the Municipality of Craiova / Dolj County Council, and was implemented in two years time duration. It was a public programme, with co-creation strategies, and partnerships for events organisation.
