\* Submitting a written commitment in the Law department of our company about not dealing with Zionist Entity and any of its establishments and companies.

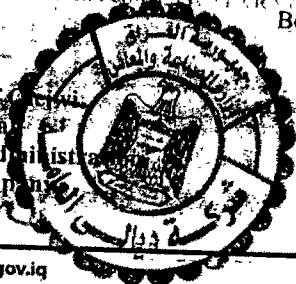
\* bidders who desire to purchase (tender documents) can visit contracting party to purchase the tender papers, also they can purchase it electronically through the electronic platform.
